FEATURED TOOL

Context: A Conceptual Framework for Understanding Political Circumstances

Purpose:

 To enhance the use of evidence in government policy making, by providing a systematic approach to understanding key dimensions of strategic decision-making in government institutions.

Description:

The framework provides six main dimensions of political context:

- 1. *macro-context*: the overarching forces (structural and circumstantial) at the national level that establish the "bigger picture" in which policy is made.
- 2. *intra- and inter-relationships with state and non-state agents*: although part of macrocontext, these warrant special mention. They are the internal relationships between the public institution and other related government agencies and the interaction with relevant users and producers of knowledge who can affect or be affected by policy design and implementation.
- 3. *culture*: the set of shared basic assumptions learned by a group.
- 4. *organizational capacity*: the ability of an organization to use its resources (human and legal) to perform.
- 5. *management and processes*: ongoing processes and policies, and how routine decisions are made.
- 6. core resources: include budget, time, infrastructure and technology.

Action Learning Action Research Association (ALARA) 10th Action Learning Action Research and 14th Participatory Action Research World Congress: The Action Learning and Action Research Legacy for Transforming Social Change

Featured conference in other (including sustainability science)

Leverage Points 2019: International Conference on Sustainability Research and Transformation

"This conference is inspired by the seminal essay by Donella Meadows "Leverage Points Places to intervene in a system". In this work, born of frustration and a deep desire for a more effective change, Meadows highlighted a series of leverage points - places in complex systems where a small shift may lead to fundamental changes in the system as a whole - for sustainability transformations.

Inspired by Meadows' work we seek to explore (in theory, methods and praxis) the deep leverage points that can lead to sustainability transformations. This conference will ask: how do we transform ourselves, our science, our institutions, our interventions and our societies for a better future? The conference is premised on three principles:

- 1. The importance of searching for places where interventions can lead to transformative change.
- 2. Open inquiry, exchange and co-learning across multiple theoretical, methodological and empirical research approaches focused on sustainability science and transformative change.
- 3. The need for reflection on modes of research and processes in sustainability research.

The conference will have a number of core themes:

- Re-structuring institutions for transformative change
- · Re-connecting people and nature as a deep leverage point
- Re-thinking how we know and act in relation to sustainability transformations
- Systems thinking and complexity as tools for transformation
- Transformative research practices in sustainability science

In the spirit of Meadows' work there will also be emergent themes dictated by inspiring research that falls outside the confines of the themes outlined above.

The closing date for abstract submission is 30 June, 2018.

The conference will be held in Lüneburg, Germany from February 6-8, 2019.
